1. Call to Order and Roll Call

5. Approval of June 13, 2024 Meeting Minutes

8. Authorization to Provide Final Payment to Thomas Irvine Dodge Nature Center for Installation of Manure Management Practices.

Construction of the Manure Management Practices for the Thomas Irvine Dodge Nature Center contract in West St. Paul, Mississippi River Watershed is complete and has been certified by staff. The project was approved for funding at the April 11, 2024 Board meeting at 85% cost share not to exceed \$12,325.

24.070 Motion by Zanmiller, second by Johnson to provide final payment of \$12,325 to Thomas Irvine Dodge Nature Center (24-IPP-01) for Installation of Manure Management Practices. Project funds are available through our FY23 State Cost Share Grant and Dakota County Capital Improvement Program (CIP). Members voting in favor: Chamberlain, Dee, Johnson, Raney, and Zanmiller. Motion carried.

9. Authorization to Execute Contract with Minnesota Department of Natural Resources for Conducting Groundwater Level Monitoring Services.

The DNR provided a FY25 Joint Powers Agreement (JPA) to conduct groundwater level measurements at various observation wells in Dakota County. The term of the agreement is July 1, 2024 to June 30, 2025. Per this contract, 38 observation wells will be monitored at various intervals. The work plan includes a total of 157 well readings; and payment to the SWCD would be \$60 for each successful on-line submittal of data not to exceed \$5,880. The contract does allow for additional payments up to \$720 should they request more readings, for a total contract amount not to exceed \$6,600. The County agreement has \$18,000 for a variety of tasks under Groundwater Monitoring and Plan Implementation Support. It is anticipated that a maximum of \$1,500 would be needed from Dakota County to supplement the DNR agreement.

24.071 Motion by Raney, second by Johnson to execute contract with the Minnesota Department of Natural Resources not to exceed \$5,880. All members voting in favor. Motion carried.
